Endosorb supports the treatment of gastrointestinal disturbances and contains no antibiotic to interfere with primary treatment. Endosorb has attapulgite added to the formula to provide superior absorbency and works well with or without antibiotics. Endosorb is available as a tablet, bolus and palatable suspension.

Endosorb Tablets:

Designed to aid the veterinarian in supportive treatment of small animal intestinal disturbances.

Endosorb Bolus:

For supportive treatment of intestinal disturbances affecting cattle, calves, horses and colts. Safe, non-toxic, no milk withdrawal.

Endosorb Suspension:

Aqueous suspension flavored and sweetened for easier dosing.

Why Endosorb?

- Citrus pectin coats the gastrointestinal tract
- Carob pulp forms a soothing mucilaginous film and adds bulk to the stool
- Magnesium trisilicate and aluminum silicate act as a soothing gastric antacid.

- No milk withdrawal so it is suitable for dairy cattle

ENDOSORB BOLUS

AVAILABLE SIZES:

15.2g - 50 ct

INDICATIONS:

To aid in the supportive treatment of intestinal disturbances in horses, cattle and other ruminants.

CONTAINS:

Each 250 gram large animal bolus contains activated attapulgite with roasted powdered carob pulp, citrus pectin, magnesium trisilicate, colloidal aluminum silicate (hydrated) with artificial color and base.

DIRECTIONS:

Horses: ½ to 1 bolus

Cattle: 1 to 1 ½ bolus

Goat & Sheep: ½ bolus

Repeat at 4 hour intervals if necessary

Store in a cool, dry place

Keep out of reach of children

ENDOSORB TABLETS

AVAILABLE SIZES:

1.5g - 500 ct

INDICATIONS:

To aid in the supportive treatment of intestinal disturbances and non-specific diarrhea in canines

CONTAINS:

Each 1.5 gram small animal tablet contains Activated Attapulgite with roasted powdered carob pulp, citrus pectin, magnesium trisilicate, colloidal aluminum silicate (hydrated) with artificial color and base.

DIRECTIONS:

Canine: 5 to 25 lbs. of body weight, 1 tablet every 4 hours

16 lbs. to 50 lbs. of body weight, 2 tablets every 4 hours or as directed by veterinarian. Make water available at all times.

Store in a cool, dry place

Read and follow label directions carefully

ENDOSORB SUSPENSION

Activated Attapulgite in Aqueous Suspension. Specially flavored and sweetened for easier, convenient dosing.

AVAILABLE SIZES:

4 oz. and 1 gal

Activated Attapulgite is a heat activated mineral clay that absorbs toxins and toxic materials present in the gut of animals with symptoms of diarrhea. This absorbent action helps to relieve the irritation, discomfort and cramping associated with diarrhea

CONTAINS:

Activated Attapulgite, 750 mg per 5 mL (teaspoonful) in a base containing citrus pectin, magnesium trisilicate, water, flavors and sodium saccharin (an artificial sweetening agent)

INDICATIONS:

Endosorb Suspension is made to help alleviate the symptoms of simple diarrheas in animals. Animals being given Endosorb Suspension should have access to fresh clean drinking water in liberal portions.

DIRECTIONS FOR USE:

Shake well before using

Puppies and Kittens: 1 to 2 tsps. every 4 hours

Dogs and Cats: 1 to 3 tbsps. every 4 hours

Foals and Calves: 2 to 4 fl. oz. every 2 to 3 hours

Cattle and Horses: 6 to 8 fl. oz. every 3 hours

Pigs: 1 to 2 tsps. every 3 to 4 hours

Hogs: 2 fl. oz. per 100 lb. body weight every 3 to 4 hours

NOTE: DOSAGE SHOULD BE ADJUSTED AS NECESSARY

WARNING: If clinical signs persist after 2 or 3 days, diagnosis should be redetermined
